

## Digital Insight EASY MONEY Sweepstakes- OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** To enter the Easy Money Sweepstakes (the "Sweepstakes"), you must be a lawful permanent resident of the United States, 18 years of age or older with a unique, personal and valid social security number and must not be considered a minor in your state of residence. Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. Employees of Digital Insight Corporation (the "Sponsor") and participating financial institutions, their affiliated companies, parents, subsidiaries, service partners, and advertising and promotion agencies (collectively, "Sweepstakes Entities"), and their IRS dependents, immediate families (i.e. parents, children, siblings, spouse) and members of their households (whether related or not) are ineligible to participate in this Sweepstakes.

**HOW TO ENTER:** The Sweepstakes begins at 12:01a.m. (Pacific Time ["PT"]) on January 18, 2008 and ends at 11:59 p.m. PT on March 31, 2008 (the "Sweepstakes Period"). There are three ways to enter the Sweepstakes.

**1. Enroll as a new Online Bill Pay Customer - Online Entry:** End Users of participating financial institutions will automatically receive one entry into the Sweepstakes by enrolling in Sponsor's online Bill Pay Service during the Sweepstakes Period. Enrollments made under multiple identities or through the use of any agent or other device or artifice to enter multiple times will be deemed invalid. Limit of one new online bill pay service member entry per End User.

**2. Online Entry:** Maximum number of entries allowed during the Sweepstakes Period via Online entry is Thirty One per bill pay account. End Users of participating financial institutions will also earn one entry for each online bill payment made during the Sweepstakes Period, up to a maximum of thirty (30) payments. PLEASE NOTE: An entry is dependent upon the date in which a bill payment has been processed by the End User's Financial Institution. In order to receive an entry into the Sweepstakes, bill payments must be processed between 12:01 a.m. (Pacific Time ["PT"]) on January 18, 2008 and 11:59 p.m. PT on March 31, 2008. Bill payments processed after 11:59 p.m. PT on March 31, 2008 will not receive an entry into the Sweepstakes. Please refer to your Financial Institution's Processing Schedule for processing dates.

**3. Mail Entry:** On a plain 3" x 5" card, legibly handprint or type your name, age, complete address, city, state, zip code, home and business phone numbers (including area code), email address (if any) and your participating financial institution's name (if any). Then, mail your 3" x 5" card in a postage-affixed sealed envelope to: "Easy Money Sweepstakes", P.O. Box 4316, Manhasset, NY 11030-4316. Mail entries must be postmarked by March 31, 2008 and received by April 5, 2008. No mechanically or programmatically reproduced entries are permitted. Each envelope is considered one entry. Neither the Sponsor nor Marden-Kane, Inc. (the "Sweepstakes Administrator") will verify receipt of entries for entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged mailed entries.

**Enrolling as a new online bill pay customer will gain a limit of one entry per person. Regardless of the method used to enter the Sweepstakes, either via Online Entry, Mail Entry or a combination of the two, the maximum number of entries for online payments is 30. Limit of entries for the Promotion Period is Thirty One (31) per bill pay account or person.**

**DRAWING & NOTIFICATION:** Potential winners will be selected from all eligible entries received and/or credited in a random drawing held on or about April 30, 2008 by Sweepstakes Administrator, an independent judging organization, whose decisions are based on their sole discretion and interpretation of these official rules, ("Official Rules"), and are final and binding in all respects. In the event of uncertainty as to the identity of an entrant, the entrant will be deemed to be the holder of the applicable financial institution account accessed in each applicable Internet Banking Bill Pay session, or in the event there is more than one holder of such account then the first person named on the account shall be deemed to be the entrant, or, if neither is applicable or reasonably ascertainable, the entry may be voided altogether by the Sweepstakes Administrator. Your odds of winning a prize depend on the number of eligible entries received. The potential winners will be notified by phone, email or mail. If a potential winner cannot be reached within seven days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected. The Grand prize will be awarded.

**PRIZES:** Grand Prize (1): \$100,000 Cash. Awarded as a check. Retail Value ("RV") of the Grand Prize is \$100,000. The total value of all Prizes to be awarded is \$100,000. Odds of winning depend on the number of eligible entries received for each respective entry and drawing period. All Federal, State and local taxes related to any prize are the responsibility of the individual winners. The Grand Prize is not transferable prior to award.

In the event it is deemed during the verification process that potential winner does not have a unique, personal and valid social security number for Sponsor to report the tax liability associated with acceptance of the prize, potential winner will be disqualified and another winner selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for the Sweepstakes Entities to use said winner's name, photograph, likeness, statements, biographical information and voice on a worldwide basis, and in all forms of media, in perpetuity, without further compensation.

By participating, entrants and their participating entities agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Sweepstakes Entities are not responsible for lost, late, misdirected, undeliverable, illegible, or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants, Sponsor, or Sweepstakes Entities. If for any reason this Sweepstakes is not able to be conducted as planned, including, but not limited to, by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud or any other causes beyond the reasonable control of Sponsor or the Sweepstakes Administrator which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes and randomly draw from those entries received up to the cancellation/suspension date.
